



CLTURE Giveaway Official Rules

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

2. Eligibility.

Subject to the additional restrictions below, the ticket giveaway (sweepstakes) is open to legal U.S. residents who are 18 years or older and the age of majority in their jurisdictions of residence at the time of entry.

3. How To Enter.

To enter, participants must like the CLTURE Instagram post, follow the associated accounts, and tag friends. By participating in the sweepstakes, you agree to be bound by the sponsor's visitor agreement and privacy policy, which are hereby incorporated by reference. Incomplete, forged, altered, automated, mechanically reproduced, lost, late, misdirected, garbled, or illegible entries will be disqualified. Sponsor is not responsible for any failure to receive entries due to transmission errors or technical malfunctions of any kind, including, without limitation, failures of networks, hardware, or software, whether originating with the sender, sponsor, or the sponsor's sweepstakes application service provider.

In the event of a dispute, all online entries will be deemed submitted by the owner of the ISP account from which they were sent, provided that such person satisfies all other sweepstakes eligibility requirements. For these purposes, an ISP account holder is defined as the natural person assigned to the ISP account by the Internet access provider, online service provider, or other organization responsible for assigning ISP addresses for the domain associated with the ISP account.

All entries become the property of the sponsor. Any questions regarding the number of entries submitted or the ownership of an ISP account will be determined by the sponsor in its sole discretion. Sponsor reserves the right to disqualify any entries submitted by persons who provide false or misleading information or whom the sponsor determines to be tampering with or abusing any aspect of the sweepstakes.

4. Winner Selection and Odds.

After the conclusion of the contest period, the sponsor will select one (1) winner in a drawing from among all eligible entries received during the sweepstakes period.

5. Prize Description One (1) Grand Prize:

Subject to verification of eligibility and compliance with these Official Rules, one (1) Grand Prize Winner will receive two tickets to the event detailed in the promotional materials. The approximate retail value of the prize is \$284.80.

No refund or compensation will be paid in the event of the cancellation or delay of the event, or any portion thereof. Sponsor will not be liable if the event, or any portion of it, is cancelled or delayed. Sponsor may, in its sole discretion, attempt to reschedule for a future event. Event tickets are subject to certain terms and conditions as specified by issuer. Exact details, including seat locations, shall be determined in the sole discretion of sponsor.

6. Winner Notification and Acceptance.

Potential winners will be notified after the conclusion of the sweepstakes period at the telephone number, email address or social media account submitted. In order to claim the prize, the potential winner must respond to sponsor's notification within forty-eight (48) hours of notice or attempted notice and confirm they will be able to attend the event. The sponsor's inability to reach a potential winner after making a reasonable effort (as solely determined by the sponsor); the failure of a potential winner to respond to a prize notification in a timely manner; the return of any prize notification as undeliverable; the inability of the winner and their guest to travel within the time period specified by the sponsor; and/or a potential winner's failure to comply with any term or condition of these official rules may, in the sponsor's sole discretion, result in the potential winner's disqualification.

In such a case, the sponsor may select a substitute winner through a random drawing from all remaining eligible entries received during the sweepstakes period. 7. Publicity.

Except where prohibited, acceptance of any prize constitutes the winner's irrevocable consent to the publication or other use by the sponsor and its licensees of his or her name, biographical information, and likeness in any media, including the internet, for any commercial, publicity, or promotional purpose, without limitation, review, or approval, or additional compensation.

8. Participation.

By participating, participants agree to be bound by these official rules and the decisions of sponsor and any sweepstakes judges or administrators selected by sponsor, which are final and binding in all respects. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this sweepstakes as solely determined by sponsor. In the event the sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of sponsor which corrupt or impair the administration, security, fairness or proper operation of the sweepstakes, sponsor reserves the right in its sole discretion to suspend, modify or terminate the sweepstakes.

By participating in the sweepstakes, each participant agrees to fully release, forever discharge, and hold harmless sponsor, CLTure LLC, advertising/promotion agencies, prize suppliers, and each such company's officers, directors, employees, agents, representatives, and successors and assigns (collectively, the "released parties") from and against any claims, costs, liabilities, losses, injuries, and damages arising out of the sweepstakes, including, but not limited to, any claims for personal injury, death, or damage to or loss of property, loss of enjoyment, or any other harm whatsoever arising out of: (1) participation in the sweepstakes; (2) the quality, receipt, possession, use, or misuse of any prize; or (3) any travel or activity that is related to the sweepstakes or any prize.

10. Limitations of Liability.

The released parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by participants, printing or production errors, or any equipment or programming associated with or used in the sweepstakes; (2) technical failures of any kind, including, but not limited to, malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the sweepstakes; (4) technical or human error that may occur in the administration of the sweepstakes, the processing of entries, or the notification of any winner; or (5) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, by a participant's participation in the sweepstakes or receipt, use, or misuse of any prize. than stated in these official rules to be available and/or claimed, the sponsor reserves the right to award the prizes by a random drawing among all legitimate, eligible prize claims.

11. Construction.

If any provision of these official rules is found to be invalid or unenforceable, the remaining provisions shall remain valid and enforceable. In the event that any provision is determined to be invalid or unenforceable, these official rules shall be interpreted as if the invalid or unenforceable provision were not included.

12. Sponsor.
